
#### 2022-2023 Program Year

# **Chapter Structure Changes 2023- 2024**



### Chapter Structure Changes (Effective 2022/2024 Program Year)

- School Based Model (Preferred)
  - 1 chapter for ALL Health and Medical Sciences Programs
  - 1 Primary Advisor + CAdvisors for each program
- Program Based Model
  - 1 chapter for EACH Health and Medical Sciences Program
  - Example: Nurse Aide I + Nurse Aide II = 1 chapter
  - 1 Primary Advisor + CoAdvisors (if applicable)
- District Based Model
  - 1 chapter for ALL middle/secondary schools within the district that offer Health and Medical Sciences Programs
  - 1 Primary Advisor + CAdvisors for each participating school

# Advisor Affiliation Changes 2023-2024



### Advisor Affiliation Changes (Effective 2023/2024 Program Year)

- All chapters MUST have a minimum of 5 student members + 1 advisor affiliated annually tremain an active chapter in good standing.
- Advisors should only affiliate under one (1) chapter
  - School based chapter model preferred
- Program Based Model
  - An advisor that teaches multiple Health and Medical Sciences Programs may have their contact information listed for each Program Chapter as the Primary Advisor
  - Co-Advisor(s) must be affiliated with each Program Chapter that the Primary Advisor is not affiliated with.
- Advisors should be Health and Medical Sciences Educators.
- CTE Directors/Program Directors other faculty members who assist with supporting HOSA programming (i.e., affiliation/registration) should be affiliated as rofessional Members of the chapter instead of as a Chapter Advisor, unless they serve dual roles and are directly advising/supporting chapter members/activities.

# Virginia HOSA CE Update 2022-2023



#### State CE Changes (Effective 2022023 Program Year)

- Competitive Events Limits
  - 1 Health Science Event + 1 other Competitive Event (Any Category)
  - Any number of Recognition Events may be in addition to participating in a Competitive Event. Participation in a CE is not required to participate in Recognition Events.
- Chapter Limits
  - The table below outlines the new Chapter Limits for Teambased events (i.e., all Teamwork Category Events, CPR/First Aid, EMT, etc.).
  - Limits are based on chapter membership at the time of SLC registration.

# Virginia HOSA CE Update 2022-2023



#### State CE Changes (Effective 2022023 Program Year)

- New HOSA Competitive Events
  - Offered in Virginia for SLC 2023
    - Mental Health Promotion (Emergency Preparedness)
    - Clinical Laboratory Science (Health Professions formerly Biomedical Lab Science)
    - Emotional Wellbeing Challenge (Recognition)
  - NOT Offered in Virginia for SLC 2023
    - Biotechnology (Health Professions)
    - American Blood Centers HOSA Blood Drives (Recognition)
- Academic Testing Center (ATC) Exams
  - All 14 ATC Exams will now be available at the state level
  - 1 ATC exam built into student member SLC registration.
  - Members may choose to take additional ATC exams for an additional \$5.00 per exam.
  - There is no limit for the number of ATC exams registered for, though the member is responsible to be able to complete all exams within the testing windows at the SLC.
  - No refunds will be given if a member misses or is unable to complete all registered exams within the testing windows.
